Business Regular Member - Voting

Any individual, privately-owned, publicly-traded company or trade association whose primary business, or whose members' primary business, is to provide services relating to recording conveyance of property, taxing property, recording liens on property and providing public access to such records. A company or organization applying for business regular membership must designate one individual to represent the company as a voting member. Includes President's Circle, Titanium, Platinum, Gold, Silver, or Bronze levels.

Associate Staff Member – Non-voting

A staff member of a Regular Member may apply for Associate Membership.

Explorer Access Member – Non-voting

Explorer Access is available only to an individual, association or organization whose primary purpose is not substantially related to the processes or services of a Regular Member, but who is indirectly related to the activities in which Regular Members engage. Eligible businesses generally have fewer than five (5) employees.
